Will the Minister of **TOURISM** be pleased to state:

- (a) whether Government has identified some tribal areas of the country to promote tourism therein, if so, the details thereof; and
- (b) the amount spent in the current financial year thereon?

ANSWER

MINISTER OF STATE FOR TOURISM (INDEPENDENT CHARGE) (SHRI PRAHLAD SINGH PATEL)

(a): Ministry of Tourism undertakes promotional activities in domestic and international markets through its schemes of 'Domestic Promotion & Publicity including Hospitality (DPPH)' and Overseas Promotion & Publicity Including Market Development Assistance (OPMD). Under these schemes, Ministry of Tourism promotes India as a holistic destination under the Incredible India brand-line. As part of its on-going activities, the Ministry releases print, electronic, online and outdoor media campaigns in the international and domestic markets, to promote various tourism destinations and products of the country including tribal areas. However, specific tourist destinations identified by the respective State Governments / Union Territory for development and promotions.

Ministry of Tourism under its schemes of Swadesh Darshan, and Assistance to Central Agencies provides Central Financial Assistance (CFA) to State Governments/ UT Administrations for development of tourism infrastructure including tribal circuits in the country.

Under Domestic Promotion Publicity and Hospitality (DPPH) Scheme, Ministry of Tourism provides CFA for fairs & festivals and shopping festivals including tribal festivals. The details are as placed at **ANNEXURE - I**

Submission of project proposal by the State Governments/ Union Territory Administrations and its sanctioning is a continuous process. The projects under the scheme are identified by the respective State Governments / Union Territory Administrations
