Will the Minister of **TOURISM** be pleased to state:

- (a) whether Government has implemented Swadesh Darshan scheme to promote tourism;
- (b) if so, the central financial assistance allocated to the State of Assam under the scheme during FY 2020-21;
- (c) the State-wise details of achievements made under the scheme including Assam;
- (d) the details of monitoring mechanisms under the scheme;
- (e) whether Government has implemented the component of the development of Way-side Facility or Toilet Development Facility under the Swadesh Darshan scheme;
- (f) If so, the State-wise details thereof including Assam; and
- (g) the details of utilization of central financial assistance for toilet development during the implementation of the scheme?

ANSWER

MINISTER OF STATE FOR TOURISM (INDEPENDENT CHARGE) (SHRI PRAHLAD SINGH PATEL)

- (a) & (b): Development and Promotion of Tourism is primarily the responsibility of the State Government / Union Territory Administration. However, the Ministry of Tourism under its schemes of 'Swadesh Darshan' provides financial assistance to State Governments/ Union Territory (UT) Administrations / Central Agencies for development of tourism infrastructure in the country. The projects are sanctioned subject to availability of funds, submission of suitable Detailed Project Reports, adherence to scheme guidelines and utilization of funds released earlier etc. The details of Central Finance Assistance provided to the state of Assam during the Financial Year 2020-21 is at Annexure-I.
- (c): The projects sanctioned under Swadesh Darshan scheme are primarily related to development of tourism infrastructure in the country and they are under various stages of implementation. The details of projects sanctioned to various State Governments/ Union Territory (UT) Administrations / Central Agencies including Assam is at Annexure-II.
- (d): The projects sanctioned under the scheme are reviewed in the review meetings. In addition, the implementing agencies are requested to submit monthly progress reports and update Public Financial Management System (PFMS).
- (e) to (g): The details of the projects sanctioned under Swadesh Darshan scheme to various States/Union Territories / Central Agencies including Assam; which cover components such as wayside facilities, toilets & sanity components are at Annexure-III.
