## Foreign Tourist Inflow to India April, 2022

Ministry of Tourism compiles monthly Foreign Tourist Arrivals (FTAs) on the basis of information received from Bureau of Immigration (BOI). The following are the important highlights regarding FTAs during the month of April, 2022.

## **Foreign Tourist Arrivals (FTAs):**

- FTAs in April, 2022 were 3,92,930 with a positive growth rate of 399.2% as compared to 78,718 in April, 2021.
- FTAs during the period January- April, 2022 were 11,77,680 as compared to 4,17,460 in April, 2021 registering a positive growth of 182.1%.
- The percentage share of Foreign Tourist Arrivals in India during April 2022 among the top 15 source countries was highest from USA (21.94%) followed by Bangladesh (16.99%), UK (13.25%), Australia (9.208%), Canada (4.54%), Sri Lanka (3.47%), Nepal (3.02%), Germany (2.13%), France (1.68%), Portugal (1.66%), Singapore (1.65%), Malaysia (1.29%), New Zealand (1.01%), Netherlands (0.85%) and Italy (0.84%).
- The percentage share of Foreign Tourist Arrivals in India during January- April 2022 among the top 15 source countries was highest from USA (24.77%) followed by Bangladesh (13.12%), UK (13.12%), Australia (6.85%), Canada (6.44%), Sri Lanka (4.06%), Nepal (2.73%), Germany (1.89%), Portugal (1.69%), France (1.62%), Singapore (1.49%), Russian Federation (1.32%), Maldives (1.29%), Italy (0.92) & Malaysia (0.81%).
- The percentage share of Foreign Tourist Arrivals in India during April 2022 among the top 15 ports was highest at Delhi Airport (34.02%) followed by Mumbai Airport (14.20%), Chennai Airport (9.37%), Haridaspur Land Check Post (8.22%), Bengaluru Airport (6.19%), Cochin Airport (5.12%), Kolkata Airport (4.88%), Hyderabad Airport (4.69%), Ahmedabad Airport (3.03%), Agartala Airport (1.58%), Trivandrum Airport (1.48%), Amritsar Airport (1.45%), Dabolim (Goa) Airport (1.26%), Tiruchirappalli Airport (0.88%) and Ghojadanga Airport (0.52%)
- The percentage share of Foreign Tourist Arrivals in India during January-April 2022 among the top 15 ports was highest at Delhi Airport (38.95%) followed by Mumbai Airport (14.76%), Chennai Airport (9.78%), Bengaluru Airport

(5.52%), Haridaspur Land Check Post (5.10%), Hyderabad Airport (4.79%), Cochin Airport (4.62%), Kolkata Airport (4.49%), Ahmedabad Airport (3.81%), Trivandrum Airport (1.36%), Dabolim (Goa) Airport (1.33%), Amritsar Airport (1.00%), Agartala Airport (0.88%), Gede Land Check Post (0.84%) and Tiruchirappalli Airport (0.74%).
